# **IRTA Membership Drive Update**

Donna Sargent, IRTA Membership Committee Chair, updated the IRTA Board on progress in meeting the proposal to increase membership in IRTA at a recent meeting of the state committee. The One-Bring-One Membership Drive is designed to help increase the membership from about 36,000 to 40,000 by December 31 of 2015.

Donna reported that the drive is behind schedule. The IRTA Convention will be the last push to meet the goal of 40,000. She urged Units to make the IRTA brochures available for the taking at all meetings since it is the tool to recruiting.

Donna also inquired how units used the TRS lists that were obtained by IRTA through the Freedom of Information Act. The WCRTA has obtained the lists from IRTA but has not yet taken board action on the best way to use them to enhance Unit membership

It was recommended by Donna that units also distribute IRTA Pipeline Applications at the TRS meetings for prospective retirees to be held in October. This is a program to provide Associate Membership to those who plan to retire in the near future and get them acclimated to the IRTA and the local Units. The form is being revised and has been submitted to the Units.

IRTA Membership Director Charlie Chrisman proposed that IRTA consider giving married educators a "family discount" for IRTA membership. No action on that idea was taken by the state committee.

Are you a member of IRTA as well as a member of WCRTA? If not, it is an easy task to join. The simplest thing is to pick up one of the IRTA brochures on display at the October 19 membership meeting, complete the form inside and send it to the IRTA office. Although Steve Maxwell is the WCRTA membership chair, any officer can help you with the form to authorize the \$2.50 monthly deduct from your TRS check. That way, annual dues are almost painless. There are other options to pay for your dues, all outlined in the IRTA brochure that you can find at the October 19 meeting in Johnston City.

If you are a member of WCRTA but not IRTA, why not join now? There is strength in numbers and we need all the strength we can muster for the difficult times ahead. By the way, why not follow Donna's game plan and talk to your best retiree friend about joining IRTA with you? Neither of you will regret the decision!

## IRTA Office Moved to New Location

IRTA's long anticipated move to new office facilities only a few blocks from the Capitol is now complete. The former location is up for sale but the "soft" market for real estate in Springfield is impacting interest in a sale.

Remodeling the 4 story building is now complete with IRTA offices on the top floor. All interior walls are glass, making for a light and airy environment. There is a large conference room that can be adapted to a variety of configurations and also a smaller meeting area for committee gatherings. There is also a wall separating the staff work area from the meeting rooms but it is easily accessible. This new facility will enhance the IRTA operation for the membership and also provide rental income from those areas of the building not used by IRTA and the IRTA Foundation. An added benefit is that a 96 vehicle off-street parking lot is available for both staff and visitors and may even offer another opportunity for revenue via long-term rentals. Re: Legislative Update

On Insurance: TRS and TRIP will receive their FY 16 appropriations. Everything will be covered as usual for teachers. [However, benefits for 158,000 state and university employees and their dependents abruptly took a turn for the worse recently when Governor Rauner's officials stopped paying their health claims. These claims are covered under the state's self-insurance plan which, allegedly, can't be paid due to a lack of a state budget. Officials of the plans have agreed to continue processing claims. Employee unions have filed suit to reverse this action. It should be noted that the state is paying over \$100 million per year in interest to vendors in the state group insurance plans due to late claims payments.] On prescriptions: By now you should be using your new prescription card issued by CVS/Caremark. We were unaware that there would be a change to CVS and this did cause problems for some of us. Note: Most drugstores will accept this card—not just CVS.

A brief history of our insurance plan: The Teachers' Retirement Insurance Program (TRIP) officially began on July 1, 1995, after the federal government notified the Teachers' Retirement System that TRS could no longer use pension money to subsidize health insurance for retired teachers. It was at this time that teachers came very close to not having an insurance plan operated by the State. It took some intense lobbying to salvage the plan. I recall my recently retired friends and I "stormed" the Capitol and spent the day talking with legislators, arguing our case.] TRS had been authorized to operate the health insurance program since 1980. Prior to that time, health insurance for retired teachers was totally at the discretion of the teacher's local school district. The 1995 legislation created several funding sources for the new health insurance program – active teachers, school districts and the state of Illinois as well as premiums paid by TRIP participants. Participant's premiums were subsidized by the plan from 50% to 75%. In general, the benefits of this new program, operated by the Illinois Department of Central Management Services (CMS), were similar to the benefits for retired state employees since the state retiree plan already had in place a system of physicians, hospitals and other medical providers as well as PPO/HMO companies. A Medicare Advantage (MA) plan was added a couple of years ago for those retired teachers who qualified for Medicare. Once again this new MA plan was based on a similar plan that AFSCME, the state's largest employee union, negotiated with the State for retired state employees. Finally, further legislation created a TRIP Advisory Task Force, composed of the plan's stakeholders (IRTA, IEA, IFT, school administrators and school boards), to oversee the program and to make recommendations to the Director of CMS for benefit changes. Additional legislation limited the amount of increase in retired teachers' health insurance premiums to 5% from year to year. Jim Bachman, Executive Director of IRTA, is a member of the Task Force. (Info provided by Rich Frankenfeld, TRS)

Other Developments: [A] Republican lawmakers are pitching a new plan aimed at reducing the state's pension debt. The plan is called an "exchange option" and would be voluntary to the retiring employee. It would offer a smaller up-front payment rather than a traditional annuity. While it does not propose to eliminate the entire pension debt, it notes that any reduction is a positive step. Its sponsors are requesting hearings to discuss it in the near future. [B] The current state master contract has been extended to Sept. 30. Major sticking points include raises, overtime, and health insurance. [C] Former lieutenant governor Sheila Simon has announced that she will seek the Democratic nomination to succeed retiring Republican State Senator David Leuchtefeld. [D] The absence of a state budget is increasingly affecting the execution of a broad variety of programs. Williamson County Board of Commissioners is considering suing the state to secure its funding. [E] Illinois Policy Institute is not our friend. They are registered as a 501-C-3 nonprofit, making all contributions tax deductible. They favor limited taxes and businesses. Too, the Chicago Tribune speaks against teachers' benefits/unions and is very pro-business. Add also Reboot Illinois and Illinois for Growth and Opportunity. We teachers are certainly not anti-business; we should not be criticized by these groups because we receive our pensions and health insurance through the state of Illinois.

At a recent meeting our guest presenter, Ellen York, who is with the Illinois Attorney General Consumer Fraud Division at the Carbondale office, presented information on scams, identity theft, credit card fraud, etc. A few of her suggestions follow:

- \* Scams If you have a complaint with a local business or contractor have a consumer advocate to mediate by calling her office in Carbondale (see listing at end)
- \* Identity theft if anyone calls asking for personal information hang-up a smart phone app can give a fake telephone number even one from your local bank or even a relative or friend
- \* A golden ticket for scams is getting your social security number never give this out your Medicare Card number is your social security number make a copy of your Medicare Card if you need it for insurance purposes and place it in your wallet but block out the last four digits when asked by a health provider then give the last four digits
- \* Credit card I have had this to happen three times scam artists will get your credit card number and will make a new card with your number our card company will automatically block or contact us to make sure this is a proper charge if not they will block future transactions, will not charge for any fraudulent transactions on the card, and will issue a new card within two days with a new number at no cost

The Minutes of the August 13th Membership meeting were corrected to show that Loren Taylor was also in attendance. Tom Oates made a motion to accept Minutes with the correction. Mary Lou Gander seconded. All in favor; motion passed.
