The winter WCIRTA membership "breakfast meeting" is scheduled for Friday, February 7th at Crab Orchard Golf Course Restaurant at 9:00 a.m. This will be an opportunity to "meet your legislators." Illinois State Representative Dave Severin and Illinois State Senator Dale Fowler have indicated that they will attend. We extend an invitation for all WCIRTA members and guests to attend and discuss current issues with our legislators. The breakfast cost to be paid by each member is \$7.95 + drink.

2020 yearly membership dues (\$10) can be paid at the February meeting or mailed to WCIRTA treasurer Kent Carrell (311 South 4th Street- Marion, Illinois 62959.)

Seven board members attended the IRTA biennial convention in Springfield in October. Bob Campbell was recognized for his service to education and WCIRTA. John Harland was elected Area Six representative serving the southern-most twenty-two counties. John Flaherty was selected as the incoming IRTA President.

Unlike the Illinois State Government constitutional officers, southern Illinois has strong representation on the IRTA Executive Board. Vice President Bill Funkhouser is from Godfrey, Treasurer Donnie Ostrom is from Mascoutah and Secretary Doris Heaton (of Heaton vs. Quinn fame) is from Benton. John Harland from Marion is our Area Six Representative while Judi Harland is a member of the IRTA Foundation Board of Directors.

In a recent TRS newsletter, Executive Director Dick Ingram wrote that Governor J.B. Pritzker recently signed legislation consolidating 649 police and fire pension systems into two statewide authorities. But little noted was that Governor Pritzker within that bill also: (1) Expanded the TRS Trustee Board from 13 to 15 members adding one elected member and one non-TRS member to be appointed by the Governor; (2) The Illinois State Superintendent of Instruction will no longer be the TRS chairman but the chairman will be appointed from the sitting TRS Board by the Governor; and (3) no more than 4 of 5 active TRS Trustees can belong to the same "statewide teacher organization." The TRS Board was originally formed in 1939 with a 5 member board and the board was last expanded in 2009 from 11 to 13 members.

The IRTA Foundation, in addition to its member assistance program, also sponsors college scholarships for junior and senior teacher education students and also monetary grants for current classroom teachers. Information is available on-line at the IRTA Foundation website.

The WCIRTA will be contacting and hosting a dinner for new 2020 retirees from Williamson County schools on Tuesday, April 21st. Each new retiree will receive a complimentary one year membership for WCIRTA and encouraged to join the state IRTA organization. There were fifteen Williamson County retirees in 2019 which we hope will remain participating members of WCIRTA in 2020.

We would like to extend our appreciation to Don Kragness for his many years of service to the WCIRTA as a board member and treasurer. With Don's resignation from the board, we will be approaching some of our loyal WCIRTA members with the opportunity to join the board. The stipend is not very large (zero) but the service is worthwhile!!!

The decade-long effort to fix the Tier 2 benefit structure finally may be bearing some fruit. In December, Gov. JB Pritzker signed a new law that consolidates the investment functions of 649 local police and firefighter pension systems into two statewide authorities. This move doesn't affect TRS at all.

While it's disappointing that these Tier 2 fixes are limited in scope and don't affect our members, the good news is that finally – after nearly 10 years – state officials are recognizing the problems Tier 2 created and are taking some first steps to make things right.

The changes enacted in December, unfortunately, do not address the major problem of the financial inequity faced by all Tier 2 members. Fixing the inequity at TRS would likely cost billions of dollars because the solution is to eliminate the Tier 1 subsidy. You either lower the Tier 2 payroll contribution or raise Tier 2 benefits. In both instances, eliminating the subsidy would increase costs for state government.

At TRS we're going to watch carefully how the Tier 2 fixes for police and firefighters work out, both administratively and financially. These changes to state law could be expanded in the future to cover other Tier 2 members – including teachers.

The new statute also makes a change to the TRS board president. For more than 80 years, the state superintendent of education by law has served as the TRS board president. Under the new law, the governor will appoint the TRS board president from among the sitting trustees. The current state superintendent, Dr. Carmen Ayala, will continue to serve as "ex officio" member of the board.

The main TRS office in Springfield has earned an Energy Star certification from the U.S. Environmental Protection Agency for significantly reducing energy use over the course of the last year

In the last five years, the annual energy cost of the TRS Springfield office fell by more than \$67,000 from \$197,057 to \$129,605.

The Government Finance Officers Association of the United States and Canada (GFOA) awarded a Certificate of Achievement for Excellence in Financial Reporting to TRS for its Comprehensive Annual Financial Report for the fiscal year ended June 30, 2018. This was the 30th consecutive year that the System has achieved this prestigious award.

If you received a TRS benefit in 2019, the Office of the Comptroller will mail an IRS Form 1099-R to you by Jan. 31, 2020. This form will report your income received from TRS during 2019.

I officially begin as the Area 6 Representative on January 28th. I, specifically, want to thank Williamson County Retired Teachers for their support, and generally, want to thank the units in District 18 for their support when I ran for the Area 6 Representative position.

I want to share with you the following information . 1) I will never apologize for the pensions that retired educators receive. Retired educators followed the guidelines prescribed by the State of Illinois every paycheck. The State of Illinois failed to follow the guidelines for the pension payments. The failures by the State created the financial problems that the State faces. 2) I will never support negotiation to reduce the benefits that retired educators receive. The Illinois State Constitution clearly addresses the fact that educators benefits cannot be reduced. 3) There was a time that I did not think that as retired educators that we needed to be politically active. That time has passed. I support IRTAPAC that is the political action arm of IRTA and I encourage all members of IRTA to support IRTAPAC financially. You may do this by have \$1/month donated to IRTAPAC by having TRS take out \$1/month out of your annuity check. If you have a question about how to do this I will be happy to assist you. 4) I am supportive of the IRTA Legal Defense Fund. Presently, we are not involved in any legal action against the State of Illinois. But I donate to IRTA Legal Defense Fund annually so if the time comes, IRTA has financial resources to immediately respond. 5) Finally, I am supportive of IRTA Foundation that helps retirees, future teachers, and active teachers with financial support. In the last 13 years IRTA Foundation has helped retired teachers, future teachers, and active teachers by contributing \$1,276,338 in form of stipends, financial payments, scholarships, and grants. That amounts to almost \$100,000/year. The funds for this assistance comes from charitable donations by IRTA members.

I will represent you and the other retired educators in Area 6 for the next four years to the best of my abilities. I thank you for allowing me to serve you as your Area 6 Representative.
