I would like to thank Marge Mangan for her years of service on the Board of Directors. Marge has decided to step down from her position as Member Benefits Director. If any of you are interested in becoming a part of the Board of Directors please talk to someone currently on the Board.

**Re:** Legislative Update

Following the fall veto session, some highlights of interest to our organization include:

• A bill enacted to outlaw local "right to work" zones was vetoed by the governor. Such zones would allow individuals to work on projects without being members of a union. A large majority of the Senate voted to override the veto. However, the House voted to sustain the veto by one vote, with Representative Severin included in the majority. The bill was thus defeated.

- Another vetoed bill would require state agencies to submit their expenses to the Comptroller on a monthly basis (rather than yearly). Both houses voted in overwhelming numbers to override the veto, and the bill becomes law.
- **Finally, the governor decided not to use his veto** on a bill that allows the funding for abortion for Medicaid recipients as state-insured employees. The bill becomes law. **Senator Fowler and several groups are attempting to challenge** the bill in court. One such effort was tossed out by a state judge on December 28.

<u>Janus vs. AFSCME</u>—The U. S. Supreme Court agreed to hear this case, and it will likely be argued in January. If the case is upheld, employees represented by public unions will not be required to pay dues called "fair share" contributions. Consequently, the strength of unions likely will be severely impacted. This case was instigated by Gov. Rauner.

March 20, 2018 Primary Election—Filing is well underway for the Primary. Largely because of his proabortion stand, Governor Rauner is being challenged by Conservative representative Jeanne Ives. J. B. Pritzker, a strong poll leader among a large field of Democrat candidates, has the support of several labor groups, including the Illinois Education Association and the Illinois Federation of Teachers.

<u>State Debt</u>—"Old" debts (some dating back to 2015) to vendors are now being paid by funds received from about 5 billion in bond sales. Bond interest is much lower than the interest that would accrue to the vendors.

<u>New Leader</u>—A new director has been appointed to lead the prestigious Paul Simon Public Policy Institute at SIU. John T. Shaw, a native of central Illinois with vast experience working with governments at all levels, will lead the non-partisan service center. Its timely studies, surveys, and interviews are an important data source.

Statement from TRS Executive Director Dick Ingram—"State government got a budget in 2017. But TRS got less money. Despite this reduction in fiscal year 2018 state support, TRS has—and will have—more than enough money to pay benefits for the foreseeable future. We currently have about \$50 billion in the bank. Total investment income last year was \$5.5 billion. Annually, our benefit payments total about \$6 billion. Still, the \$500 million reduction in the state's contribution is important for the long-term future of TRS. Our latest actuarial report shows TRS is 40 percent funded."

President of IRTA, David Davison, is pleased to report significant achievements recently that position the Association to defend member interests at the capitol, to increase membership, to provide greater service by our Springfield Office, and to continue to offer excellent benefits and activities. IRTA, is now, a well-known and influential organization in Springfield. He also is happy to report that the Lutheran Family Services has rented our old Springfield Office which we still own.

The most important legislative achievement this summer was to save subsidies for the Teachers Retirement Insurance Program. These subsidies help to reduce the cost of our premiums for health insurance.

The IRTA continues to change and adapt to members' needs. The process for membership can be done totally, electronically online. We have added 3800 new members in the last two years and are hoping to reach a total increase of 4000 by the end of 2017. AMBA which provides many benefits is very involved in helping to enroll new members.

The IRTA Foundation continues to offer "Scholarships" and "Grants to Acitve Teachers' Programs. The Foundation is administered independently of Association monies.

Over 460 members recently attended our Biennial IRTA State Convention. From the Convention the following statements were offered in "The Path Forward":

- 1. We believe any attempts to take away our health insurance benefits will fail.
- 2. We are ready, willing, and able to fight any further efforts through litigation.
- 3. We should be proud of how our Association has and will continue to respond.

Proposed amendment changes and the updated constitution can be found online.

The Illinois Retired Teachers Association will convene informational meetings in Florida for Illinois annuitants with regard to IRTA activities. Meetings are scheduled for February 12, 13, and 15, 2018, in the Villages, Sarasota and Naples.
