Representative Bradley then opened the floor for a Question and Answer session:

Concerns:

- * the cost shift -- to force local school districts to pay more.

- * 2015 -- Illinois' fiscal cliff.
- * Reforming the tax system.
- * "If I made a sacrifice, would it matter?"

* "If we sacrifice, can we depend on the legislators and the Governor to take the money and get rid of the debt?"

Mr. Bradley addressed other issues:

- * Medicaid roles need to be cleaned up.
- * Our concern should also be with pensions for the current teachers.

Following the Q&A session, Mr. Bradley left for his next appointment.

Mr. Ozment then told of the IRTAPAC. The Legal Defense Fund would pay lawyers to take our fight to the Courts. Donations are accepted by going to IRTA.org or giving them to John Harland.

Bob Campbell reported that there will be a doctor at our next meeting (May 7, 2013). Dr. Bernard Rerri, Mt. Vernon, Illinois, will address issues to maintaining our health. The May meeting will be at Mackie's in Marion. Our August 14 meeting will have a speaker from the Insurance House.

Dee asked the Board to find out who is retiring from the local schools in our County.

Wanda Riley from Marion commented: "Thanks to Tom Oates for the excellent job he did." Mr. Ozment reported that Connie Beasley has left the Board after many years of service.

There being no further business and a motion being made, seconded, and passed, the meeting adjourned at 10:45 A.M.
