Bill, who has been the Area 6 representative to the board for ten years, has also announced his candidacy for Vice-President of the IRTA. He will update the members of WCIRTA about current happenings relative to retired educators and will explain his vision for the next several years if he is elected as vice-president of IRTA. Bill has been to several WCIRTA meetings in the past and his comments are always well received.

#### **Re:** Legislative Update

The Non-Cycle: Thank goodness the recent eclipse gave us a temporary diversion from what used to be referred to as the "election cycle." Instead of being a cycle, elections now preoccupy us from one day to the next without any recognizable letup. This abuse of our brain's ability to digest facts (and separate fact from fiction) has been greatly fueled by modern technology such as Facebook, twitter, cable news, smart phones, the internet, Google, TV commercials, partisan newspaper look-alikes, apps, etc. Also, many politicians seem to devote much of their time catering to major contributors rather than their constituency, resulting in added confusion. About all the typical retiree can do to cope is stay as broadly versed as possible while relying on their professional organizations, such as IRTA, for guidance. Ear plugs and blinders might help a little, too.

School Funding Bill: After being unable to override the governor's veto of SB1, the legislature finally passed a compromise school funding plan on August 29. It provides for a new funding formula which will result in additional monies for the state's 800 school districts and is focused on reducing disparities between rich and poor schools. Additionally, it provides \$75 million in tax credits for people who contribute scholarships for private schools. It is estimated that these will assist about 10,000 students. The credits would be worth 75 percent of a taxpayer's scholarship contribution, with a maximum of \$1 million annually. It will expire in five years unless re-enacted by the legislature. Students receiving scholarships must be from a family within certain income limitations (approximately \$73,000 for a family of four). Scholarships must be given to a specific school, not to a specific student. This portion of the funding bill is generally opposed by teacher unions and some school officials. Finally, the new legislation provides funds to Chicago Public Schools to assist them in making payments to its teacher pension fund.

<u>Cost of living Adjustment</u>: For those retirees receiving social security benefits, the Social Security Administration will announce its adjustment for the coming year in October. The increase will be based on the current consumer price index which is based on the rate of price inflation. Although most of us are aware that the cost of things keep going up, especially health care, annual increases over the past few years in social security checks has been only less than one percent. For the coming year, however, the Senior Consumer League estimates the adjustment for 2018 to be around 2.1 percent. As noted, the exact amount will not be announced until October.

<u>911 Change—New Tax:</u> Based on a new state mandate, Williamson County (and all others with a population less than 250,000) is consolidating its emergency 911 call centers that previously operated in Marion, Herrin, and the Sheriff's department. Under the new arrangement by the Emergency Telephone Service Board, Marion will now handle 70 percent of all Williamson County's 911 calls. The added expense will be funded by a charge of about one dollar on cellphone bills.

<u>Change in 118th District:</u> Long-serving representative Brandon Phelps has resigned his seat in the 118th representative district for health reasons. His appointed successor is his cousin and daughter of former Congressman David Phelps, Natalie Phelps Finnie. A nurse, wife, and mother, she plans to run for the office in next year's election. Her potential republican opponent is the current Massac County State's Attorney, Patrick Windhorst.
