Legislation was signed that allows a person to opt back into our teacher insurance program if they so desire. This was a much needed fix, especially for those that had accidentally lost their coverage by mistake. Another interesting bill that was passed would allow a retired teacher to go back into the classroom and teach in an area of need during this school year without affecting their pension. The position has to be declared an area of need because of a lack of teachers in that subject or area. So those of you who have been dying to get back into the classroom this is your chance.

Our next meeting will be Thursday, October 18 at 12:00 pm. The location will be at Mary's in Herrin at a cost of \$16 with tip included. The meal was excellent last year and the meeting area was very nice. Bill Funkhouser, IRTA Area 5 representative and Paul Strid, AMBA representative will provide the program. During 2018 the Board of Directors decided to update the active membership list by making personal contact with every WCIRTA member whose name appears on the roster. Each Board member contacted approximately 30 members. One surprising result of this contact was to find that we have more than 200 people on the roster who are not current on paid dues. Even more revealing was that more than half of those are still on the membership list but have not paid dues since the 2014 calendar year or before. (An active member is one who has paid dues for the current calendar year.)

After discussing this matter the Board determined that it should maintain a membership list that included accurate contact information for ONLY those members who have paid dues for the current year. The Board also decided that any person on the present list who has not paid dues since 2015 could become current simply by paying the current year's dues of \$10.

Those members who have not made recent dues payments but who wish to be included on the current membership roster should make a \$10 dues payment for 2018 to the WCIRTA Treasurer prior to January 1, 2019. After January 1, 2019 an updated list of members and current contact information will be prepared that represents the members who are current with their WCIRTA dues. Re: Legislative Update Fr: Anna Morris

**Dear Fellow Retirees:** This is my final column for the newsletter. After serving on the WCIRTA Board for 24 years, I will be retiring at the end of this year. Resigning from the board was not an easy decision, since it has been an important part of my life since retirement. When my former principal, Bud Rushing, would not accept "no" for an answer at the retirement tea provided by the board, I agreed, never thinking I'd be there 24 years later —and earn an "honorary degree" in political science in the process. Athel Tanner, a wonderful man, was the president. Both he and his wife are now gone, as are many others with whom I served on the board through the years. When I joined, I reasoned that I could possibly make a difference in improving the benefits available to our older retirees who could not help themselves. Working with legislation has added an extra dimension to my education, and my contribution to the betterment of the lives of retirees has been very meaningful to me. Many changes have taken place since 1994; the computer is being used instead of the telephone, the costly bus caravans to Springfield are no longer necessary, and area and regional representatives' road trips to units in Southern Illinois are not as frequent. In 1995 teachers came close to losing state health insurance and, in more recent times, our 3% COLA. We were able to get a second elected annuitant on the TRS Board, also very important. Through the years there were many bills that required our attention to better the lives of our retirees. Just when there seemed to be a lull and all was well, something inevitably popped up that jeopardized either the health care or retirement benefits. IRTA, founded in 1955, is an important organization that has worked for us through the years and one that needs our support. In this context, every retiree needs to sign up for VoterVoice at the IRTA website (www.irtaonline.org) and respond to the emails when they are received. We can't rely on a few people to carry the load and think that all will be well. Please know that it has been my pleasure to serve as legislative chair for the past 24 years and to have participated in the advances we have attained. I'd like to thank all our members for giving me your support and ask that you continue to work with our officers in making our unit a vital organization—one of the best in Illinois.

Good News: Governor Rauner signed into law SB3046 on August 21, 2018. Eligible TRS recipients and TRS dependent beneficiaries may elect to participate in TRIP (this includes participants in TRAIL) if they previously opted out of the program. The election must be made during the benefit recipient's annual open enrollment period, subject to specified conditions. Senator Manar and Rep. Gordon-Booth were the main sponsors of this legislation. Return to Work Legislation: This one-year program allows a TRS retiree to return to work without postretirement limitations. The regional superintendent must designate the employment to be in a subject shortage area in order for a retiree to be able to return to work without limitation. The program expires on June 30, 2019. On August 26, Governor Rauner vetoed the bill that would have raised the minimum salary of full-time public school teachers to \$40,000 over the next five years. He reasoned that it would be an unnecessary state mandate and that it was an inefficient way to compensate teachers. From the Chicago Tribune, quoting Rauner: "Things like pay-for-performance, diversified pay for teachers in hard-to-staff schools or subjects, or pay incentives for teachers with prior work experience are all viable options to provide greater compensation for teachers." Sen. Manar may try to get the veto overturned in the veto session, which begins on Oct. 24 and lasts two weeks. TRS Annuitant Trustee, Daniel Winter, will be retiring in 2019 and IRTA is seeking a member to replace Winter. For several years we were blessed to have Cynthia O'Neill and Bob Lyons representing us on the board. This is an important, demanding job. It is in our interest that we have excellent representation on the board which has 13 members (six trustees appointed by the governor, four trustees elected by contributing TRS members, and

two trustees elected by TRS annuitants, and the state superintendent of education).
