Dear Fellow Retiree.

The holiday season is over and I trust that all of you had a pleasant interlude with family and friends. WCRTA business usually slows during this season but that means we need to get back to business quickly after the new year starts. Retired teachers are still waiting for the other shoe to drop with a new governor and some changes in the makeup of the legislature. The Illinois Supreme Court will review the lawsuit that was ruled on—favorably to us—by Circuit Judge John Belz in Sangamon County in the fall. Illinois Attorney General Lisa Madigan asked that the court review the suit in an expedited manner, meaning they will likely take action in the next 3 or 4 months, probably before the General Assembly adjourns for the summer. We will relay pertinent information as it is received from IRTA and others.

The uncertain future demands that we remain involved and keep ourselves informed of actions affecting the future of our pensions by all three branches of state government. One of the best ways to do so is to join IRTA. Membership is available by payroll deduction at the rate of only \$2.50 per month. There are other membership payment options available at www.IRTAonline.org. IRTA is the only organization devoted exclusively to issues pertinent to education retirees and needs the support of every TRS annuitant. You need to be a member of BOTH our local Williamson County Retired Teachers Association and also the Illinois Retired Teachers Association! Please consider joining IRTA now! (There are more than 350 members of WCRTA but over 50 of them (that is 1 of 7) have not yet joined IRTA.

A second item we all need to do is to provide financial support to IRTA in the fight for our constitutionally guaranteed pension benefits. We should support the legal actions being undertaken on our behalf through a contribution to the Legal Defense Fund of the IRTA. **No dues money is being spent for the legal challenge to the state's actions.** All expenses are paid by contributions to the Legal Defense Fund. Thus far individual donors have contributed nearly \$400,000 to the effort—but our legal expenses have already exceeded \$300,000 with the biggest challenge yet to come. IRTA President Bob Pinkerton has a letter detailing this issue on the IRTA website. I urge you to read it and then send your contribution to IRTA at 620 N. Walnut, Springfield, IL 62702. Designate Legal Defense Fund in the memo line of your check.

Finally, we need to be a part of the solution to prevent similar legislative actions in the future by getting involved in the political process through joining the IRTAPAC. Again, it is a nearly painless system of providing \$1.00 per month through payroll deduction to support the election of those representatives who are in accord with our agenda. Go to the IRTA website and make your commitment today.

You should receive this newsletter in time to attend the winter **WCRTA meeting at Crab Orchard Golf Club at 9:00 AM on Friday, February 13.** Our local legislators have been invited to speak to our membership at that meeting. Come and listen and do not hesitate to ask them the hard questions.

Finally, I reiterate my usual plea to remain vigilant; become better informed; let our legislators know how we feel; join and support IRTA; sign up for and use IRTA's Voter Voice; join IRTAPAC and, most importantly, send a personal check to IRTA for the Legal Defense Fund.

Support the Legal Defense Fund

As the state legislature begins its 2015 deliberations WCRTA and IRTA members throughout Illinois need to continue to be involved in the process. President Bob Pinkerton's letter to members (go to www.irtaonline.net to read the letter) details the need for local members to be involved. Specifically, he calls for continued contributions to the Legal Defense Fund by the IRTA membership.

You have just received your February check reflecting the 3% compounded increase that is your constitutionally guaranteed annual increase divided by 12. Compare the amount of that February check with that of the check you received in January. That is the amount that would have been reduced significantly by the actions of the legislature, had not IRTA and others filed legal action to fight the reduction. IRTA could do this only because of financial contributions by the membership and others to the Legal Defense Fund.

Our president says IRTA is grateful for each and every contribution regardless of the amount and urges all to respond to his plea. He also suggests that a good rule of thumb to follow for making your contribution to the Legal Defense Fund is to send in the equivalent of that one month's increase, or the difference between what the check was that you received in January and the one you received in February. I for one plan to do that, although I have already sent in two checks previously. Will you join me and make a contribution to the Legal Defense Fund? You and all retired teachers throughout Illinois will be the beneficiaries.

Re: Legislative Update Fr: Anna Morris

When the founders of our State Constitution were writing it, they went to great debate and lengths to be precise in its language. Specifically, they sought to assure teachers and other public employees that their pension benefits would not be terminated or eroded with the language that this membership "shall be an enforceable contractual relationship, the benefits of which shall not be diminished or impaired."

Still, Illinois lawmakers through Public Act 98-0599, formerly SB1, said these constitutional words could be refuted. Further, retired teachers and other public employee organizations have been forced to spend millions of dollars defending these words.

In a late November ruling declaring PA 98-0599 unconstitutional, Judge Belz wrote in his opinion, "The State of Illinois made a constitutionally protected promise to its employees concerning their pension benefits. Under established and uncontroverted Illinois law, the State of Illinois cannot break its promise." He declared the law "void in its entirety." Further, he noted that the State's defense of the law as unconstitutional under its police powers was "no legally valid defense." Attorney General Madigan appealed the ruling to the Illinois Supreme Court who agreed to consider it in their March 2015 session. [Schedule: appellants' brief—Jan. 12/appellees' brief—Feb. 16/appellants' reply—Feb. 27/oral argument scheduled for the March 2015 term of court. Note: After typing this info, I learned today that our lawyers have requested an extra month to file arguments. John Fitzgerald, one of our lawyers, stated there are new arguments that need to be evaluated.]

While Judge Belz' opinion stands a good chance of being upheld by the Supreme Court, other assaults on our pensions seem likely. Some pundits are advocating taxing retirement income. Governor Rauner has stated that he does not support such a tax or constitutional amendment. He has previously suggested a separate defined contribution plan for future employees.

Governor Rauner was sworn into office on January 12. Members of the upcoming legislative session took their oaths the following day. Phone numbers and email addresses for elected officials are included in this newsletter (as found in <u>The Southern</u>).

At the end of fiscal year 2014 last June, TRS assets were 45.8 billion up from 39.9 billion. The funded ratio stays at 40.6 percent. TRS remains among the worst funded pension systems in the nation.

Highlights of Board of Directors Meeting

Next meeting is February 13 at Crab Orchard Golf Course. Breakfast cost wil be \$6.25 for buffet; \$1.50 for coffee or tea; \$1.95 for juice or other drinks; plus tax and tip.

Steve Maxwell has updated the new website and calendar of about 357 members, there are only 89 hard copies of the newsletter that have to be mailed. There have been three deaths among membership; Margaret Jones, Brenda Preston, and Helen Cast.

John reported that Senate President John Cullerton and Governor Bruce Rauner "want nothing to do with Retirees." Attorneys are expected to file briefs in February. There is no new legislation.

Discussed increasing membership to WCRTA and a possible increase in dues. This would be brought to the membership. Area 6 meeting in Carbondale will be held on May 7 instead of May 1.
